

# GAIA RETREAT CENTER – TERMS AND CONDITIONS

## Renting Villa Gaia [as a Retreat / Workshop / Teacher Training facilitator]

Please note as we receive many inquiries and requests for reservations all Villa bookings are on a first come first serve basis. Bookings are only confirmed when a downpayment is received.

A payment plan can be worked out to accommodate your needs as follows:

### 1 installment

To honor this 1 part plan, we will absorb any excess international fees whether you choose to pay via bank wire transfer or paypal

### 2 installments

50% upon booking and 50% 1 month before retreat starts no % fee.

To honor this 2 part plan, we will absorb any excess international fees whether you choose to pay via bank wire transfer or paypal

### 3 x installments

33.33% upon booking and 33.33% for the second downpayment and 33.33% final third downpayment.

#### **Strict late payment charge of \$200 usd applies**

Must arrive in the bank anytime before payment due date which will be highlighted in your invoice.

Please include 40 USD for international wire transfer to cover excess cost and 3.5% for PayPal - per transfer.

### 4 x installments

Your total investment will be divided equally across 4 installments

#### **Strict late payment charge of \$300 usd**

Must arrive in the bank anytime before payment due date which will be highlighted in your invoice.

Please include 40 USD for international wire transfer to cover excess cost and 3.5% for PayPal - per transfer.

## Cancellation by facilitator

- Cancellations made up to 6 months prior to arrival date; 50% of your deposit is credited towards another date, 12 months from your original retreat date.
- Cancellations made less than 6 months prior to arrival date your deposit is NONREFUNDABLE.
- If you are late on the deposit due the balance due is still owed.
- Cancellation notification has to be written by email, CC to all relevant parties in the email chain and sent again if no one has responded in 3 days.

## Cancellation by Guest [Detox & Yoga Retreat / Transcendental Meditation Retreat]

- A portion of your detox retreat or TM retreat payment may be rescheduled towards another date within 12 months from original date of booking if you require to cancel as follows:

**100% of your payment is transferred to a new date, if cancellation is made 45 days or more prior to check-in.**

**50% of your payment is transferred to a new date, if cancellation is made 21 – 45 days prior to check-in.**

- No refunds or reimbursements are made under any life circumstances or emergency situations.
- We do not offer credit for arriving late or leaving early. There are no partial refunds for any services not used while the retreat is going.
- The 50% balance of your payment is due one month before your arrival for your retreat.
- If you are booking within the same month of your arrival date, your balance of 100% payment is due.

### Cancellation Policy, Risks and Insurance

- Facilitators and all guests must assume complete and full responsibility for and hereby release PT. Gaia Retreat Center, Villa Gaia, the owner/s, the employees or anyone involved in supplying any services during the length of the proposed travel and retreat booking.
- PT. Gaia Retreat Center & Villa Gaia, shall not be responsible for any injuries, losses or damages in connection with accommodations, other facilities at the resort, ground transportation, diseases, Acts of God, local laws, climatic condition delays, changes or cancellation of travel due to weather conditions, accidents or health related problems while residing at Gaia Retreat Center & Villa Gaia, and while in-transit to (e.g., an accident on the way to a tour or into town etc), during, and after a tour.
- In case of force majeure, act of governing law, climatic condition disruption which forces Gaia Retreat Center to cancel our own in-house retreats (ex: Detox / Transcendental Meditation) your full payment will be credited to another date within 12 months from date of original booking. Please see above.
- It is the traveler's responsibility to obtain appropriate insurance coverage against these risks. You can purchase Travel Insurance when you purchase your airline ticket with most airlines and travel agents.
- If travel plans are delayed or cancelled for any reason there will be no refunds issued by Gaia Retreat Center, except as stated above.
- We specifically recommend that foreigners entering Indonesia do so with a valid Passport expiring more than six month following the departure date from Indonesia.
- Gaia Retreat Center & Villa Gaia, are not responsible for expenses incurred in preparation for any cancelled trips by a guest such as flight cancellation or illness, airline tickets complications or for costs incurred due to travel delays.
